Chapter 1 of 2012 Special Session transfers \$276.5 million of general fund revenues to the Budget Restoration Fund. The total is comprised of \$247.3 million from Personal Income Tax; \$7.4 million from Corporate Income Tax; \$8.8 million from State Lottery Receipts; \$5.0 million from Tobacco Tax; and \$8.0 million from Motor Fuel Tax.

The extraordinary revenues in 2013 include a GAAP transfer of \$17.5 million.
